**THE DAYTON TOWN COUNCIL MET MONDAY January 3,  
2011 AT 7PM IN THE DAYTON TOWN HALL. COUNCIL  
MEMBERS PRESENT WERE MIKE BOAS, MIKE HARRIS, RON  
MERKEL, JOHN SWICK, JOE BUMBLEBURG, TOWN ATTORNEY,  
WAS ALSO PRESENT.**

Mr. Bumbleburg, as Temporary Chairman, called the meeting to order.

Mr. Bumbleburg opened nomination for President of the Town Council.

Mr. Swick made a motion to nominate Mr. Harris as Town Council President.

Mr. Merkel seconded the motion and the motion carried.

Mr. Bumbleburg, made a motion to close the nomination for President.

Mr. Swick seconded the motion and motion carried. Mr. Harris was thus elected.

Mr. Harris opened nominations for Vice President of the Town Council.

Mr. Swick made a motion to nominate Mr. Boas as Vice President for Town Council.

Mr. Merkel seconded the motion and the motion carried.

Mr. Bumbleburg, made a motion to close nominations for Vice President, Mr. Swick seconded the motion the motion carried.

Thus Mr. Boas was elected.

Mr. Harris moved that all officers stay on the same committee position as they were in 2009.

Mr. Boas /Finance and Salary.

Mr. Swick / Health and Welfare and Area Plan.

Mr. Merkel Street Department.

Mr. Swick said a letter needed to send to Sally Fahey of Area Plan that Mr. Swick was Area Plan Representative.

Mr. Swick made a motion to approve the minutes as written.

Mr. Merkel seconded the motion and motion carried.
