Rocky Richards called the Utility meeting to order. Present were Carla Snodgrass, Marc Buhrmester, Rocky Richards, Steve Schuhle and Mike Harris. Also present were Patrick Jones, Town Attorney, Cindy Florey, Clerk-Treasurer, and Robert Taylor, Town Marshal.

Discussion on ROW directional boring/Frontier Communications.

**Town Manager**

- Kurt stated that he passed the State Operators test and is now a Certified Water Operator. There are still two missing valves. They used sonar recently to find a water line attached to a valve. Carla asked where the two valves were located. Kurt stated one by MacAllister's that leads to Deerfield and one across the tracks on Dayton Road.
- Kurt stated that he has done 296 locates so far this year. That averages out to 26 per month.
- Kurt asked Marshal to speak on adding the maintenance trucks to the Fleet car wash we have with Crew Car Wash. To add undercarriage wash and have it for all the towns vehicles would be \$600 a year. Mike made a motion to purchase the \$600 car wash for the town vehicles recurring each year without coming in front of the Council and Carla seconded the motion. Roll call vote, Mike-yes, Steve-yes, Rocky-yes, Marc-yes, Carla-yes. Motion carries 5-0.
- Steve ask Kurt to compile a list of buildings, fences, and patios built on any easement. Then to make residents aware that if we need to tear their property down to repair our utilities, we are not liable to rebuild the homeowner's property.

**New Business**

- **Adjustment Report:** Rocky made a motion to accept the Adjustment Report for October 2025 in the amount of \$-590.17. Seconded by Carla. Roll call, Mike-yes, Steve-yes, Rocky-yes, Marc-yes and Carla-yes. Motion carries.

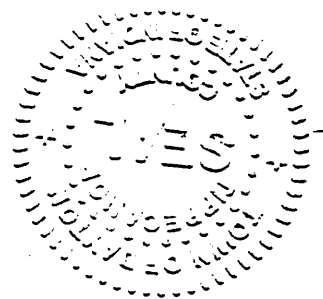
