Marc Buhrmester called the meeting to order. In attendance were, Marc Buhrmester, Steve Schuhle, Leah Copas, Rocky Richards, and Carla Snodgrass. Also present were the Town Attorney, Alicia Albertson, Clerk-Treasurer, Bridget Cadwallader, and Deputy Tislow.

Opening of Trash Collection Bids:

Alicia opened the bid from TK Trash Kans. She read the bid. Year one and year two are \$14.00 per unit, monthly cost of \$7980.00, annual cost of \$95,670.00. Year three is \$14.70 per unit, \$8379.00 per month, and an annual cost of \$100,548.00. Year four is \$15.44 per unit, \$8800.80 monthly, and \$105,609.60 annually. This includes two dumpsters in the fall and two in the spring. The second bid was opened from T&L Disposal LLC. Year one is \$14.77 per house, Monthly cost \$8418.90, Annual cost \$101,026.80. Year two per house is \$15.03, Monthly cost is \$8,567.10, and Annual cost is \$102,805.20. Year three is \$15.33 per house, Monthly cost is \$8738.10, and Annual cost is 104,857.20. Year four is \$15.71 per house, Monthly cost is \$8954.70, and Annual cost is \$116,411.10. It includes two times a year roll-off dumpsters for clean-up. Marc noted a discrepancy between the year four monthly charge and the annual charge from T&L Disposal. Marc discussed the four-year totals of both companies and noted the difference in pricing of \$18,468.00 over the four years. Alicia stated that both companies pick up recycling. Rocky mentioned T&L picking trash up outside the totes. Alicia did not see anything in their bid regarding this. She did state that TK Trash Kans will pick up additional garbage in trash bags outside of the tote. Carla asked if both companies met the bid requirements. Alicia confirmed that both companies met the requirements. Leah made a motion to accept the bid from TK Trash Kans. Marc seconded the motion. Carla had a clarification question that we are accepting years one and two. Alicia explained the contract for years three and four. Roll call vote. Steve-yes Leah-yes, Rocky-no, Marc-yes, Carla-yes. Passes4-1.

Lawn Waste Ordinance:

Marc discussed the revised lawn waste ordinance. Marc made a motion to suspend the rules and read by title only. Carla seconded the motion. Roll call vote. Steve-yes, Leah-yes, Rocky-yes, Marc-yes, Carla-yes. Passes 5-0. Bridget read Ordinance 2024-8 by title: "Ordinance 2024-8 An Ordinance Regarding Street Sanitation." Marc made a motion to suspend the rules and pass on first and second

reading Ordinance 2024-8. Steve seconded the motion. Roll call vote. Carla-yes, Marc-yes, Rocky-yes, Leah-yes, Steve-yes. Passes 5-0. Marc made a motion to adopt ordinance 2024-8 on the first and second reading. Carla seconded the motion. Roll call vote. Steve-yes, Leah-yes, Rocky-yes, Marc-yes, Carla-yes. Passes 5-0.

Deadly Force Resolution:

Marc made a motion to adopt Resolution 2024-9 Deadly Force Resolution. Steve seconded the motion. Roll call vote. Carla-yes, Marc-yes, Rocky-yes, Leah-yes, Steve-yes. Passes 5-0.

Purchase New Flag Poles:

Marc discussed the old flag poles. We ordered two new flag poles. Nate installed them. He discussed the cost being \$40.00 for a two pack from Amazon. We would new 49 poles. We would order 50 poles at approximately \$1000.00. Leah made a motion to order new poles. Carla seconded the motion. Roll call vote. Steve-yes, Leah-yes, Rocky-yes, Marc-yes, Carla-yes.
