- **City of Lafayette Water Rates:** Discussed a letter received from the City of Lafayette about a possible water rate increase.
- **Cemetery Lift Station:** Cemetery lift station was plugged up recently causing a backup of the line to SR 38. Kurt is recommending having the lines jetted out and the other lines inspected. Mike made a motion for Kurt to get an estimate on jetting out that line and to check on pricing of jetting the other lines in town. Steve seconded the motion. Roll call vote, Carla-yes, Marc-yes, Rocky-yes, Steve-yes, Mike-yes. Motion carries 5-0.
- **Approving 5 Extra Hours.** Rocky made a motion to approve 5 extra hours for Mark Harlow who filled in for Kurt who was on vacation in August. Steve seconded the motion. Roll call vote, Mike-yes, Steve-yes, Rocky-yes, Marc-yes, Carla-yes. Motion carries 5-0.
- **New Utility Clerk:** Rocky made a motion to hire Susan Scheffer as the new Utility Clerk. Carla seconded the motion. Roll call, Mike-yes, Steve-yes, Rocky-yes, Marc-yes, Carla-yes. Motion carries 5-0.

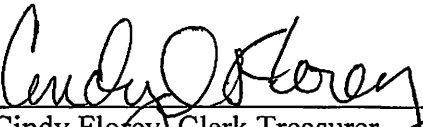
Public Comment
