Bridget explained the 2025 Fire Contract in the amount of \$36,465.00. Marc made a motion to accept the Fire Contract for 2025 in the amount of \$36,465.00. Steve seconded the motion. Roll call vote. Carla-yes, Marc-yes, Rocky-yes, Steve-yes. Motion carries. Bridget asked the board for approval for Cindy to spend \$300.00 on Halloween decorations for town hall and candy to pass out on Halloween at the gazebo. Marc made a motion to allow \$300.00 to be spent on decorations and candy. Steve seconded the motion. Roll call vote. Carla-yes, Marc-yes, Rocky-yes, Steve-yes. Motion carries.

Area Plan Representative Report:

Town Manager:

Crack seal/ surface/ stripe update. Steve gave detail on this for the police department lot and finish town hall. He discussed the bids. Steve made a motion to move forward with Bright Lines doing the crack seal, surface, and striping at the police station and the rest of town hall. Marc seconded the motion. Roll call vote. Police Report:

Steve asked that Alicia look into the ordinance that West Lafayette adopted and word it to fit the needs of our town.

Marc made a motion to extend an offer to Kurt Delzer for \$52,000.00 a year, \$500.00 monthly healthcare stipend, and \$25.00 monthly cell phone stipend. Steve seconded the motion. Roll call vote. Carla-abstain, Marc-yes, Rocky-yes, Steve-yes. Motion carries.
