ORDINANCE NO. 2023-13

AN ORDINANCE TO APPROPRIATE ADDITIONAL FUNDS

WHEREAS, Indiana Code § 36-1-3-4 provides a municipality all powers necessary to conduct its affairs, even if not expressly granted by statute;

WHEREAS, the Town Council of the Town of Dayton, Indiana (hereinafter the "Council") has determined it is now necessary to appropriate more funds than was appropriated in the annual budget; and

WHEREAS, the Council hereby finds it is in the best interest of the Town of Dayton, Indiana, and its taxpayers to make such additional appropriation pursuant to Indiana Code.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAYTON, INDIANA, AS FOLLOWS:

Section 1. Be it ordained by the Council, that, for the expense of the taxing unit the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to the laws governing the same:
