ORDINANCE NO. 2023-4

AN ORDINANCE TO ESTABLISH OCRA GRANT FUND

WHEREAS, Indiana Code § 36-1-3-4 provides a municipality all powers necessary to conduct its affairs, even if not expressly granted by statute;

WHEREAS, the Town of Dayton, Indiana (hereinafter the “Town”) applied for a grant from the Indiana Office of Community and Rural Affairs (hereinafter “OCRA”) and has received or will receive funds from the grant for the purpose of the preparation of a comprehensive plan for the Town;

WHEREAS, the Town has determined it is necessary to establish a fund, the OCRA Grant Fund, which shall be funded by said OCRA grant proceeds; and

WHEREAS, such fund shall continue in existence until such time as all the monies within the fund are exhausted, and after their exhaustion, shall be terminated.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAYTON, INDIANA, AS FOLLOWS:

1. There is hereby established the OCRA Grant Fund to receive funds from the OCRA grant proceeds for the purpose of the preparation of a comprehensive plan for the Town.
2. The fund shall continue in existence until such time as all the monies within the fund are exhausted, and after their exhaustion, shall be terminated.
3. No part of this Ordinance shall be interpreted to conflict with any local, state, or federal laws, and all reasonable efforts should be made to harmonize the same. Should any section or part of this Ordinance be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the Ordinance as a whole, or any portion thereof other than



that portion so declared to be invalid, and for this purpose, the provisions of this Ordinance are hereby declared to be severable.

4. This Ordinance shall be in effect upon its adoption.
