## Ordinance 2024-<u>25</u>

## SALARY AND COMPENSATION FOR ELECTED OFFICIALS FOR 2025

WHEREAS, Indiana Code Section 36-5-3-2 states the Town legislative body shall fix the compensation of its own members, the Town Clerk-Treasurer, the Town Marshal, and other Town officers and employees.

WHEREAS, the Town Council and the Town Utility Service board wish to establish salaries for the year 2025.

NOW, THEREFORE, BE IT ORDAINED by the Town Council and the Town Utility Service Board that the following salary schedule shall be in full force and effect on January 1, 2025, and the following stipend shall be in full force and effect upon passage of the ordinance. The ordinance reflects bi-weekly payroll amounts.

This stipend shall not constitute compensation for purposes of Indiana Code Section 36-5-3-2.

The Town Council approves a one-time stipend to be paid in quarterly installment by March 31, 2025, June 30, 2025, September 30, 2025, and December 31, 2025, for the following elected officials in the following amounts:

Clerk-Treasurer:\$20,000

Such stipends shall not constitute compensation for purposes of Indiana Code Section 36-5-3-2.
