ORDINANCE NO. 2024-8

AN ORDINANCE REGARDING STREET SANITATION

WHEREAS, Indiana Code § 36-1-3-4 provides a municipality all powers necessary to conduct its affairs, even if not expressly granted by statute;

WHEREAS, the Town of Dayton, Indiana, (hereinafter the "Town") adopted Chapter 92: Nuisances in the Town of Dayton, Indiana Code of Ordinances; and

WHEREAS, the Council believes it is in the best interest of the Town to amend Chapter 92 to add provisions regarding street sanitation to prohibit the deposit of various materials including but not limited to grass, refuse, junk, debris, weeds, limbs, etc, on the streets of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAYTON, INDIANA, AS FOLLOWS:

1. The Town of Dayton, Indiana, Code of Ordinances is hereby amended by amending Chapter 92 to add Section 92.45 as follows:

§ 92.45 STREET SANITATION.

(A) It is unlawful for any person, firm, or corporation to deposit, throw, or sweep into or upon the streets, alleys, rights-of-way, or sidewalks of the Town any paper, rubbish, dirt, trash, crates, boxes, garbage, junk, or other refuse of any kind.

(B) It is unlawful for any person, firm, or corporation to deposit, throw, or sweep into or upon the streets, alleys, rights-of-way, or sidewalks of the Town any grass, weeds, leaves, limbs, or tree trimmings, or brush of any kind.

(C) Residents may rake and move leaves into piles during posted times of leaf collection to the area immediately adjacent to the street, alley, right-of way, or sidewalk for collection, but it shall be unlawful to deposit, throw, or sweep leaves into or upon the streets, alleys, rights-of-way, or sidewalks. If there is an area between the curb or street and sidewalk, residents may deposit leaves in the area between the curb or street and sidewalk.

2. This amendatory ordinance shall be effective upon passage and posting in accordance with Indiana law.
